WHEN IT ALL BEGAN

The year was 1995 and Swedish development assistance needed to sharpen up. Civil society was missing a platform to jointly advocate for a better world and improve Sweden's aid policy. It was in this context that two great forces for human rights and democracy became one even greater.

It all began when the Swedish Volunteer Cooperation (Svensk Volontärsamverkan, SVS) and Aid Information for Volunteer Organisations (Biståndsinformation för frivilligorganisationer, BIFO) merged to form Sweden's largest platform for civil society – Forum Syd.

The result was a new stronger voice to broaden the discussion on how we can achieve a better world with development cooperation between people within civil society. Forum Syd became the new platform for civil society organisations to discuss ways of making Swedish development cooperation even more coordinated and strategic. A firm voice of expertise and willpower to rely on.

The organisation has since been a broad platform for popular participation of the people through a diverse range of Swedish organisations. All united with one common interest of achieving the freedom and rights of people all over the world.


Over the decades we have seen how global civil society is growing in importance. Today, states


WHO WAS BIFO AND SVS?

The Swedish Volunteer Cooperation (SVS) consisted of about 60 popular movements and non-profit organisations and was financed by Sida. SVS worked directly with the public sector in, among others, Nicaragua and Zimbabwe by, for example, sending nurses and teachers as volunteers. BIFO was an association of volunteers whose mission, on behalf of Sida, was also to examine applications and administer grants for various projects around the world.

In the 1980s, these two organisations had the joint mission to inform the general public about Swedish development organisations' work. The collaboration also included lobbying and investigating activities on social conditions for aid workers, counselling and training for member organisations.

SUPPORTING THE CIVIL SOCIETY

Forum Syd enables effective popular participation through civil society. All people are holders of human rights and have the knowledge to describe their own problems and propose solutions. Change is only sustainable when determined, implemented and owned by the affected communities. Our Rights-Based Approach offers new perspectives and solutions, achieving progressive change with people at the core.

Forum Syd's change work is therefore always done together with the local civil society where people gather to claim their rights and stand up for democracy.

Sustainable change with people at the centre of development

Forum Syd have since 1995 channelled over 3 billion SEK towards a just and sustainable world in which all people are empowered to improve their life conditions. When people defend and build democratic societies, common resources become more equally shared and poverty declines. Power for change is generated when people organise themselves and become aware of their rights.

Since the very beginning supporting civil society has been the essence of our cause. Sustainable and lasting change for democracy can only happen when it is done together and claimed by the people who will live and breathe in it. Forum Syd have over the years built a unique expertise; both technically and thematically on how we support civil society to become actors of change.

WOMEN'S RIGHTS ARE HUMAN RIGHTS

Gender equality is a human right and a prerequisite for achieving democratic societies and sustainable development. If poverty is to decrease, all people regardless of gender must participate in society on equal terms. We work for an equal society in which all people enjoy the same rights, opportunities and resources.

WE CHANGE PEOPLE'S LIVES

A just and sustainable world requires new attitudes from discriminatory social structures. Consequently, an analysis of power hierarchies is always an integral part of Forum Syd's development work. We collaborate with strategic partners and gain in-depth knowledge of the social situation in the areas we work in. Forum Syd enables people to effect change.

WE CHALLENGE GIANTS

The role and responsibilities of the state are crucial to the fulfilment of civil rights. A strong civil society with effective organisations creates a society in which the duty-bearers can be held accountable and cooperate in a dialogue with their citizens.

WE FIGHT GLOBAL WARMING

Global warming is a daily threat to the progress that has been made by marginalised and vulnerable people. We challenge unjust power structures so that all persons can enjoy the same degree of protection from environmental hazards and have equal access to decision-making processes that affect their livelihoods and environment.

GUATEMALA

One of our many rights-based programmes focusing, besides peace-building, on civil society and strengthening its influence. Capacity building, gender equality, democracy and global development issues were all integral parts of the programme.

2001-

COLOMBIA

We support civil society as peacebuilding actors, to promote the rights of women, peasants, indigenous population, afrocolombian population and reincorporated people.

1998-

BELARUS

We empower a variety of different local groups and initiatives in Belarus, working in the fields of democracy, human rights, environmental protection, and gender equality. We specifically support organisations that are trying to influence policy changes in the country.

We support local organisations and build people's capacity to exercise their rights and participate on their own terms in the protection and management of natural resources such as fish, forest, and land.

Our programmes supported the Nicaraguan civil society and had a strong gender equality and democracy focus. An important part was the work on strategic development issues such as international conventions and commitments on gender equality, trade policy issues, and international development policy.


OUR SWEDISH PARTNERSHIP PROGRAMME

PARTNERSHIPS ARE INSTRUMENTAL




Today, Forum Syd have formal partnerships with roughly 200 civil society organisations annually and further participate in numerous networks. Through collaboration, innovation and courage, we can change anything and everything.

The power to change

The best foundation for a resilient democracy is a strong and diverse civil society; we are the watchdogs protecting against corruption and ensuring accountability. Civil society is vital for advocacy, providing information, documentation and monitoring of policies, laws and society.

As civil society we organise not only individuals but also create strategic networks with other organisations and societal actors to lobby formal and informal duty-bearers for societal-wide change.





OUR ADVOCACY

Lasting change can only be achieved when governments take action and enforce laws that ensures everyone's equal value and rights. Civil society is tasked with holding desicion makers to account and advocate for change when injustices arise.

That is why Forum Syd influences Swedish and European policies on different levels in the interests of global justice and a sustainable world. We bring change through our advocacy and that has been the core of Forum Syd's activities since the very beginning.

For the past two decades we have been a watch dog and defender of democracy and human rights. As Sweden's largest platform for civil society, our policy work is conducted in close cooperation with our member organisations and partners in Swedish and international networks. We believe collaboration is key. Only together can we push for a fair and sustainable world where all people have the power to effect change.

Throughout the years we have advocated for a number of different causes but with one common denominator; a free and independent civil society that enables people to claim their rights.

Forum Syd in the decade of 2020

2015 was a big year for global development on the political arena. The UN Sustainable Development Goals were adopted, and the world's nations reached a deal on climate change. Our priority is to make sure that the voices of people living in marginalisation are heard in such global agreements. Therefore, we have been monitoring and lobbying before and during the three world summits of the UN Sustainable Development Conference in New York, Financing for Development in Addis Ababa and the UN Climate Change Conference in Paris.

Progress in reducing poverty has been made throughout the world. Nevertheless, major inequalities remain. We need to continue to

inequalities if we want to eradicate poverty and achieve the 2030 Agenda. Forum Syd advocates for Swedish and European aid policies to prioritise the reduction of inequalities.

Forum Syd is an important voice in the debate on global justice. We influence decision makers to ensure that political frameworks contribute to a just and sustainable global development. We advocate for an active role of civil society in the implementation of the 2030 Agenda and effective development cooperation

targeting people

living in poverty. Our close cooperation with partners in countries where we operate is the key for success in our advocacy work.

When times are rough, we need ambitious development policies to ensure the quantity and quality of development aid. International aid needs to have a rights-based perspective and the actual needs of people living in poverty should form its basis. We take global commitments for aid and development effectiveness very seriously and we hold people in power to account. Because when things are tough it is not the time to surrender – it is the time to take leadership and show the way.

FROM MANUALS TO CHANGERS HUB

Over the years, Forum Syd has been an important platform for developing capacity and methods that strengthen civil society's work for democracy and human rights. Hundreds of courses, workshops, conferences, seminars and in recent years online courses have been held for a large number of organisations.

When Forum Syd started in 1995, our members agreed that the Swedish popular movements needed to strengthen their capacity to work with development cooperation. Forum Syd became the platform for idea sharing and method development with our member organisations as strategic partners.

Democratic development requires popular participation and influence at the local level.

Therefore, we begun investing in organisational development in order to strengthen the capacity of partner organisations around the world.

In the mid-2000 we started to publish our methods in book-series entitled Make gender a matter of power; Realising democracy and creating justice; Reducing poverty with young people's influence; Build democracy in the middle of conflict; and Make a sustainable environment a human right. These were later followed by the Right (s) way forward, our own methodology to identify power structures to effectively address the barriers and root causes preventing the fulfilment of rights.

We have developed our knowledge, methods

and capacity in collaboration with our member organisations through a shared learning and participatory process. The aim has always been to weave together different development perspectives on poverty reduction; democracy and human rights; gender equality; the environment and climate change; and conflict prevention work. Results and method analysis have been a main focus, not least during the years when civil society's development cooperation was questioned and debated at the end of the 1990s.

Throughout the years we have published several books in relation to development and global studies. Even though times have changed and books and printed method materials have been replaced by reports and online E-learning courses, one book is still in demand after more than 15 years.

In 2002, economist Stefan de Vylder wrote The Driving Forces of Development (Utvecklingens Drivkrafter) for Forum Syd's publishing house. He had been monitoring the global economy for several decades and wrote a unique overview and comparison of causes and management of the financial crises from the 1980s and onwards. The Driving Forces of Development describes how different development theories have emerged and discusses questions about what creates development and prosperity, what obstacles exist and what poverty looks like in the world. Since the first edition, the book has been a part of the curriculum in university and high school courses and been appreciated by thousands of readers with an interest in development issues.

In 2019 we became more digital and launched Changers Hub – a virtual learning platform to enable civil society actors to interact and learn to make lasting change happen. It offers a variety of courses on topics such as the Rights Based Approach, financial and project management and of course our methodology the Right(s) Way Forward. We continue to offer new ways for organisations and partners around the world to strengthen their capacity and build a strong and vibrant civil society.

That is quite an obvious one, that Forum Syd was founded of course. It was quite a complicated process, but all forces came together in a positive way in the end. It was great fun the day we got the organisation started on July 1, 1995, by then we had been in the process for 3-4 years.

It was the significant growth of the organisation. We became an important voice in the advocacy work together with other organisations in Sweden. The staff teams in Stockholm and in the country offices together were absolutely fantastic.

I think it was that we got the country offices into the operations in a completely different way. This meant that the managers at the country offices also sat in the management team and we had global management team meetings. 




































THE POWER TO CHANGE

Forum Syd is part of the global civil society. We are convinced that the growth of new social movements, in the broadest sense, has a key role in making the global changes for a just and sustainable world happen.

Civil society is a broad, complex arena of groups of differing ambitions, sizes and interests. The pluralism of civil society has a value in and of itself in that it gives a wide range of groups a voice and the power to affect the political agenda.

Civil society empowers people to change their lives and communities at a local, regional, national and global level. Its actors can monitor powerholders and serve as a channel for popular participation in the public debate. In order to play this role, civil society organisations must embody democratic values and be democratically legitimate and representative.

Strong partnerships build democracy globally. Swedish organisations have a long tradition of networking with civil society groups worldwide, and it was out of this collaboration of social movements that Sweden's development cooperation grew. Today, many development actors understand the importance of strengthening civil society in order to reduce

poverty and increase democracy. Still, Swedish organisations are highly instrumental in ensuring that development cooperation is collaborative. Organisations share values and can meet each other as equal partners despite coming from different circumstances.

Civil society collaborations are much more than merely sharing development projects. They are about exchanging ideas and experiences and possessing a common urge to shape policies in the interests of a more just and sustainable world. Swedish organisations can give space to the voices of organised people in their partner countries, who often find it more difficult to have their opinions heard in international contexts.
